Industrial Mission on NPT International Safeguards

# 1. Purposes of the Mission

The Treaty on the Non-Proliferation of Nuclear Weapons came into effect on March 5 of this year with 43 nations' ratification obtained. The Japanese Government, pending its ratification of this Treaty, signed it on February 3 taking the current international situations into consideration. In signing this, the Japanese Government isseed a statement that, while it did sign, in favor of the spirit underlying this Treaty, it would endeavour to reach an agreement with IAEA on the rational and acceptable system of the safeguards before its ratification, and for that system not to hamper the peaceful nuclear activities in Japan.

Japan Atomic Industrial Forum, Inc. some three and half years ago had set up Ad-Hoc Committee on the Non-Proliferation Treaty, which discussed if the stipulations of the Non-Proliferation Treaty might fix the much disadvantageous position of the nuclear industry in Japan as compared with other countries over the period as long as 25 years. And it has several times submitted views on it to the Japanese Government.

Nevertheless, a concern has been felt over whether the cause of our apprehensions for the international safeguards system has been completely removed at this stage. It is also noted that, with the coming into force of the Treaty, the IAEA is now drawing up the draft agreement on the safeguards which the Agency is required to conclude with each of the States Parties.

With these current circumstances in view, the JAIF sends "Industrial Mission on NPT International Safeguards" to the European countries and the U.S. in order to better communicate the position on that matter of the Japanese nuclear industry to those countries as well as to make study on their attitudes toward the safeguards system and how the safeguards inspection has been implemented.
